






**SECTOR BREAKDOWN (%)**

**Fund Lipper Global Classification:** The fund peer group as defined by the Lipper Global Classification.

This figure represents the estimated greenhouse gas emissions per \$1 million in sales across the fund's holdings. This allows for comparisons between funds of different sizes.
